Aims:	<ol style="list-style-type: none"><li>1. Provide a reading platform for students to share the joy of reading, enhance their self-confidence and expression skills, and express their feelings and understanding after reading books in different ways.</li></ol>
Target:	<ol style="list-style-type: none"><li>1. The family currently in receipt of the CSSA or</li><li>2. Students who have received <u>full grant</u> under the School Textbook Assistance Scheme after reviewed by the Student Finance Office or</li><li>3. Students who have received <u>half grant</u> under the School Textbook Assistance Scheme after reviewed by the Student Finance Office.</li></ol>
Quota:	40 eligible students from P.3-P.6 (If the number of applicants exceeds the quota, lots will be drawn) °
Fee:	Free of charge
Content:	<ol style="list-style-type: none"><li>1. Book Subsidy Scheme: Each student will receive approximately HK\$250 value of books.</li><li>2. "Happy reading, Book crossing" activity:<ul style="list-style-type: none"><li>● Students participating in the book subsidy scheme to carry out book crossing activities in school. After reading the book, students have to write a short book report and then clip it into the book.</li><li>● Each book on the "Book Crossing shelf" has to be circulated at least 3 times. After the event, participants can retrieve their books and read the book report enclosed in the books.</li></ul></li></ol>
Remarks:	<ol style="list-style-type: none"><li>1. Selected students will be notified individually, if students have not received the notification that means student will not be selected.</li><li>2. In order to increase the public's and sponsors' understanding of the beneficiaries, the organizer may invite the media to participate in the event, which involves shooting, video recording or interviews, and some may be used for organizational publicity and media publishing.</li></ol>
